# IN- HOME RESPITE CARE

Serving Children and Families with Disabilities Since 1963

### **Respite Services**

Through our Respite Services our agency provides short-term, intermittent care for persons with a diagnosis of Autism, Cerebral Palsy, Epilepsy or Intellectual/ Developmental Disabilities in their natural, guardian, or foster family home.

Our staff are sent into the family home to provide care for the individual with special needs, as well as any siblings under the age of 18. This allows the primary caregivers the opportunity to attend community events with the comforting knowledge that their children are being well cared for in their absence.

We also assist families in accessing other available services for their child by providing referral services and to assure that the families' needs are best met, even providing CPR/First Aid training for families at no charge.



### Free to Familes

Respite services are provided for families in southwest suburban Cook and northern Will Counties as well as the Chicago neighborhoods of Beverly, Mt. Greenwood and Morgan Park.



"Being a caregiver to my disabled son is very rewarding, but I would be lying if I didn't say the demands of daily care has not impacted my physical and emotional health. Families like mine often face unique challenges: lots of stress, grief, frustration, and profound isolation. Caring for my son who has a chronic illness is a full time job and it is easy to be overwhelmed.

For a few hours, my son can remain in the comfort of our home while a highly trained respite worker cares for him. I use my time wisely to run errands, attend to his siblings needs, or just to take a night off and catch dinner with friends. I come back home recharged; because there are so many times that families like mine are burned out from all the daily tasks that go with caring for a child with a complex medical history. As you can see, respite care is vital to our family."

### Temporary Relief For Primary Caregivers

Trained professional respite staff offer care for individuals of any age with qualifying diagnosis. Siblings under the age of 18 are included in services. The objective of the program is to provide temporary relief for the primary caregiver, while maintaining the needs of the child in the family home, rather than a more restrictive long-term out of home placement.
